STUDENT VOLUNTEER APPLICATION FORM

I have offered my services as a student volunteer to help the Center in daily classroom activities as directed by the classroom teacher, such as but not limited to:

- Model appropriate social skills while interacting with students

____ I agree to abide by all relevant Governing Board policies and administrative guidelines while on duty for the Center.

____ I understand that while volunteering in the classroom I am to meet the needs of the classroom teacher and students.

____ I understand I am not to use personal or school electronic devices while volunteering in the classroom. If I have school work to complete I will notify the classroom teacher that I will report to study hall rather than volunteer.

____ I understand that, although I am covered under the Center's liability insurance policy, I am not covered by its health insurance policy nor am I eligible for workers' compensation. Should I become ill or suffer an accident while doing volunteer work for the Center, I agree that I shall be responsible for any and all hospital and medical charges that may accrue.

____ I understand that, as a volunteer, I am not in any manner considered an employee of the Center or entitled to any benefits provided to employees.

____ I release the North Point ESC Governing Board from any and all liability for any damages, whatever their nature, which may result as a consequence of my volunteer services.

____ I have never been convicted of any of the following offenses: aggravated murder, murder, voluntary manslaughter, involuntary manslaughter, felonious assault, aggravated assault, assault, aggravated menacing, abuse or neglect of a child, kidnapping, abduction, child stealing, criminal child enticement, rape, sexual battery, corruption of a minor, gross sexual imposition, importuning, voyeurism, public indecency, felonious sexual penetration, compelling prostitution, promoting prostitution, procuring prostitution, disseminating matter harmful to juveniles, pandering obscenity, pandering obscenity involving a minor, pandering sexually-oriented matter involving a minor, illegal use of a minor in nudity-oriented material or performance, endangering children, contributing to the delinquency of children, carrying concealed weapons, improperly discharging a firearm at or into a school or house, corrupting another with drugs, placing harmful objects in or adulterating food or confection.
